Rules applied:

- * Service Periods are close to 30 days between meter reads; Bill date is 11-12 business days from meter read date.
- * Due Date is on or close to the last day of the month.
- * Penalty date is 3-4 days after due date (10% late fee applied and Notice mailed/e-mailed to customer)
- * If you do not receive a utility bill in the mail, it does not exempt you from receiving a late fee, as the City has alternate means to receive a bill/get bill information.
- * If you choose to mail your payment to our office, please confirm with City Staff **before the due date** that it has been received. Payments mailed before the due date but received after will still incur a late fee. Note: You may want to consider using alternative payment methods such as bank draft, online bill payment, or by phone at 1-866-277-1417.
- * This calendar is being provided in good faith and with the understanding that dates may change due to unforeseen factors, and in the event of a discrepancy, the due date printed on your bill supersedes this calendar. Holidays included are federal bank holidays and city holidays in which the office is closed.
